GENERAL PRICE LIST – Effective April 11, 2019

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Basic Services of Funeral Director and Staff and Overhead..... \$3300

Our charge includes funeral counseling, necessary arrangements, recording vital statistics, securing permits, filling and obtaining death certificates and other forms and claims, preparation of necessary notices, and coordination of services plans with parties involved in final disposition of deceased. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

Embalming..... \$995

Except in certain cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

This charge includes basic services of staff, local transportation to funeral home and casket coach to local cemetery or crematory, (excludes visitation & funeral ceremony)

Direct Cremations..... \$2979

Our charge for a direct cremation includes local removal, care of remains, transportation to crematory, basic services of staff & authorizations (excludes ceremony, visitation & crematory charges.)

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without outside covering) The containers we provide are:
