HOWEVER, ANY FUNERAL ARRANGEMENTS YOU SELECT WILL INCLUDE A CHARGE FOR OUR SERVICES. If legal or other requirements mean you must buy any item you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

CALIFORNIA SALES TAX WILL BE ADDED TO ALL TAXABLE ITEMS. This list does not include prices for certain items that you may ask us to buy for you; such as, but not limited to, outside cemetery or crematory services, flowers, motorcycle escorts for outside processions, and newspaper notices. The costs for these items will be shown on your bill or the statement describing the funeral goods and services you selected. We charged you for our service for placement of newspaper notice including cost.

### SERVICES OF THE FUNERAL DIRECTOR AND STAFF

Our service charge includes consultation with the family, clerical and administrative services, preparation and filing of necessary permits, coordinating the details with cemetery, crematory, and/or other parties responsible for the arrangements made. Also a percentage of this fee is necessary to cover a proportionate share of our established overhead costs such as licenses, insurance, and indirect taxes (does not include sales tax on items in the merchandise category), maintenance of facilities and equipment, utilities and a host of other costs related to being in business to serve the public.

If you do not want embalming, you usually have the right to choose an arrangement that does not require it, such as direct cremation or immediate burial. If embalming is declined and the final disposition of the deceased is not completed within 8 hours from the time of death, we require refrigeration.

Our charge for a direct cremation (*without ceremony*) includes transfer of remains to our funeral home (within a 20 mile radius), attempting to obtain the death certificate, and file necessary permits, services of funeral director and staff, other preparation of body (refrigeration), and delivery to Utter McKinley Mortuaries.
