BASIC SERVICES OF THE FUNERAL DIRECTOR AND STAFF \$2,290.00

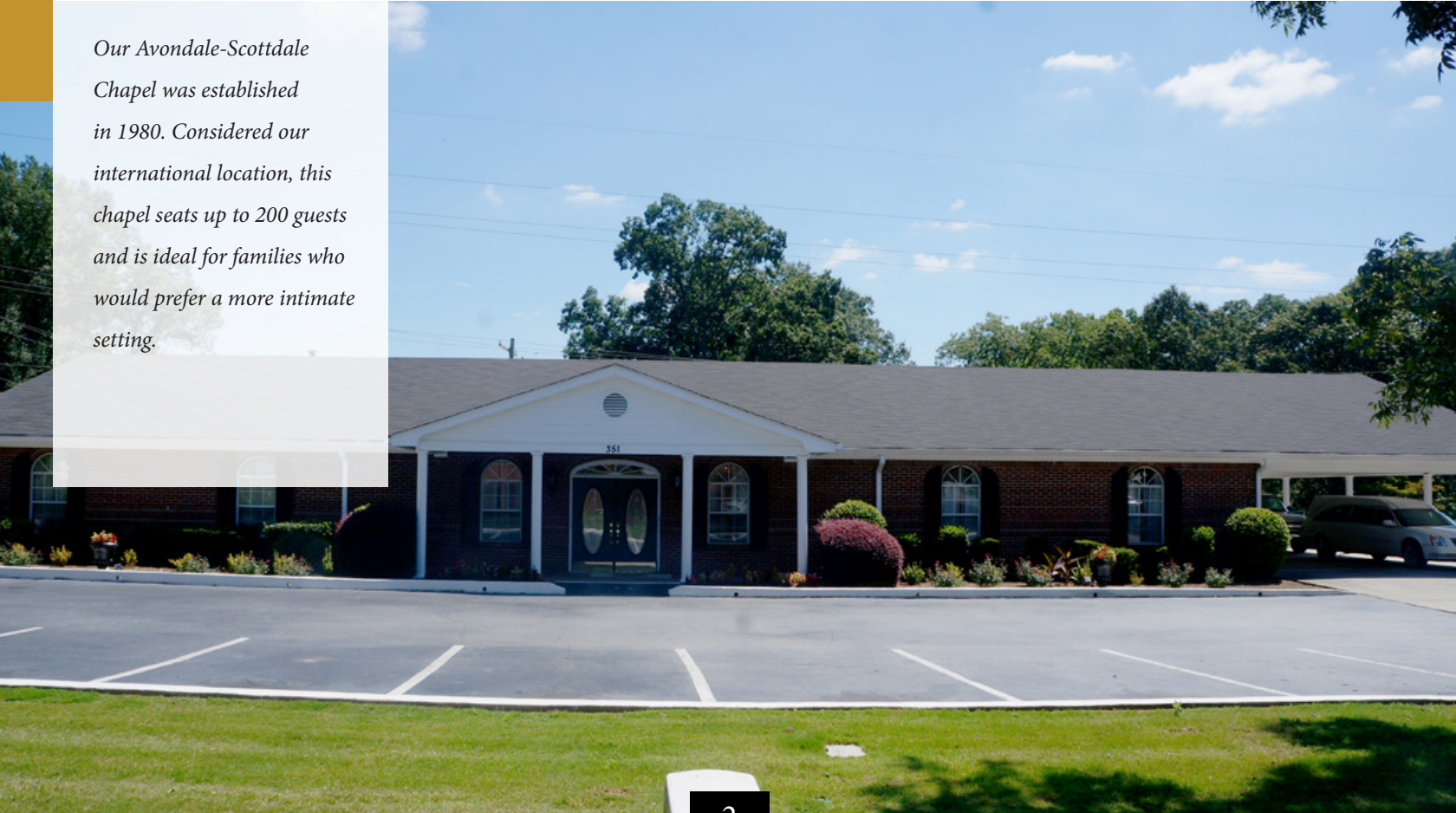
The fee for the services of the funeral director and staff includes, but is not limited to:

EMBALMING _____ \$1295.00

If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

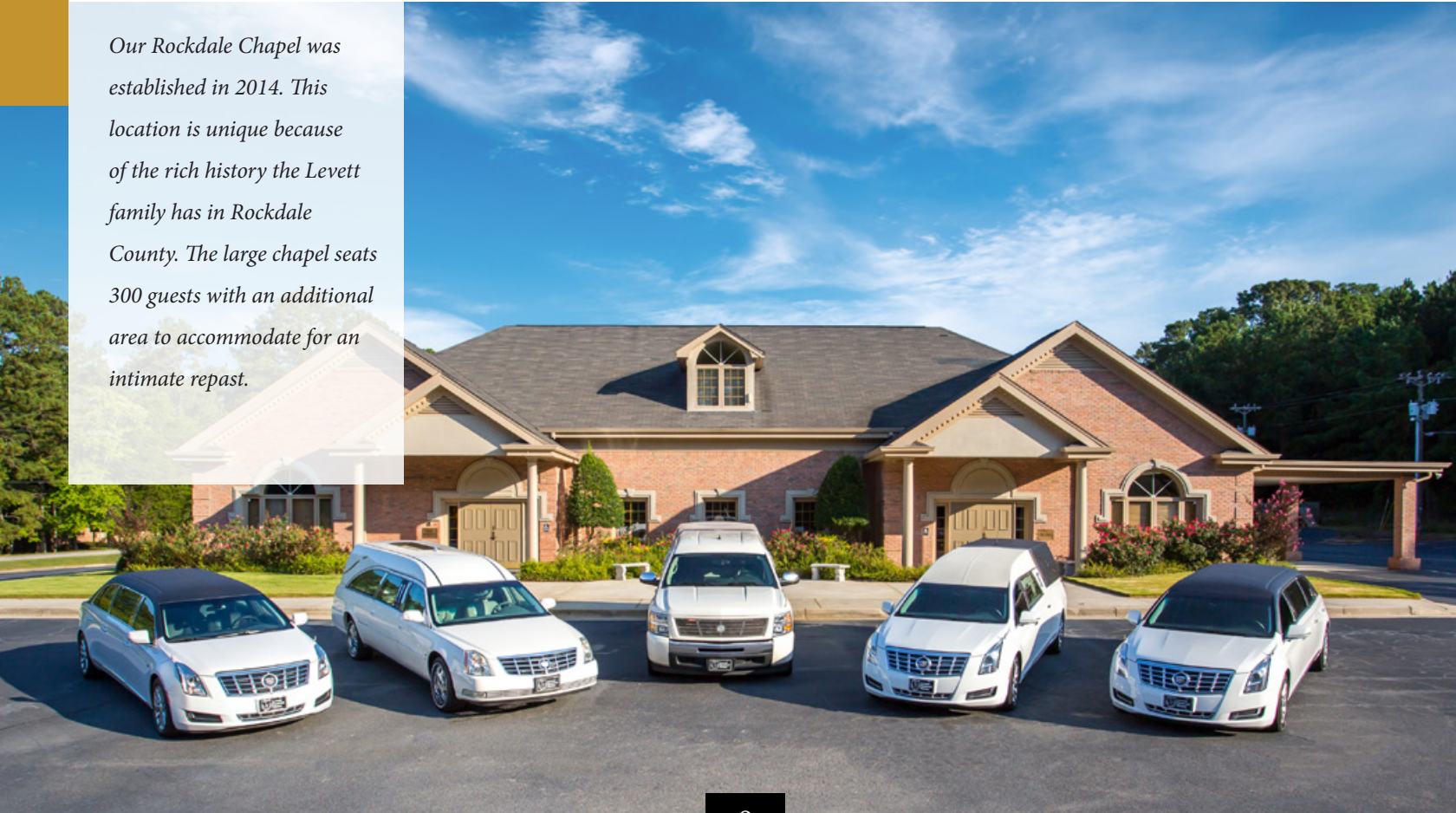

Our Rockdale Chapel was established in 2014. This location is unique because of the rich history the Levett family has in Rockdale County. The large chapel seats 300 guests with an additional area to accommodate for an intimate repast.



CREMATION SERVICES **\$2,480.00**

Our charge for a direct cremation without any attendant, rites, or ceremonies includes removal of remains, necessary services of staff for authorizations and cremation charge. Our crematory requires the human remains be placed in a minimum alternative cremation container to enable us to place the remains into the cremation chamber for cremation. Alternative containers encase the remains and can be made of materials like heavy corrugated cardboard, fiberboard or composition materials. Plus one cremation urn with **no viewing of remains**.

MEMORIAL SERVICES **\$3,995.00**

This charge includes removal arrangement, memorial service, urn, and portrait.
All containers provided must meet any applicable state or crematory requirements.

- **Direct Cremation with private family viewing (Within 48 hours)** **\$4,020.00 AND UP**
(1 hour visitation, no embalming, 10 person max)

All services included in direct cremation, as well as the bathing of the deceased, and 1 hour family viewing. This includes a trayview cremation container. **(Non-embalmed remains plus a cremation urn)**

- **Direct Cremation with Embalming** **\$5,615.00**
(Includes 1 urn. 4 hour visitation. This includes a trayview cremation container. No ceremony)

- **Traditional Services with cremation (Including a casket)** **\$8,405.00 AND UP**
These charges includes removal of remains, services of director and staff, preparation/embalming, dressing, and cosmetizing, use of facilities for one day visitation, church or chapel service, necessary automotive equipment and cremation charge. Includes 1 urn and portrait.

- **Immediate Burial Services (Within 72 hours)** **\$5,065.00 AND UP**
