Basic Services of Funeral Director and Staff

\$895.00

Our fee for the basic services of funeral director and staff includes, but is not limited to, staff to respond to initial request for service; arrangement conference with family and responsible parties; preparation and filing of necessary authorizations and permits; recording vital statistics; preparation and placement of obituary notice; and coordination with those providing other portions of the funeral and others as required. Also included in this charge are overhead expenses relative to our facilities such as professional licensing, legal and accounting fees, insurance, building and utility expenses, parking lot and grounds, maintenance, taxes, equipment, furnishings, inventory costs, record keeping, secretarial and administrative expenses.

Direct Cremation Packages

Our charge for direct cremation of individuals less than 300 lbs. without ceremony includes: basic services of funeral director and staff, refrigeration, transfer of deceased to funeral home (within 25 miles), crematory fee, cardboard cremation container, and temporary plastic urn.

SPECIAL CHARGES

Forwarding of Remains to Another Funeral Home \$2,895.00

This charge includes: transfer of deceased to funeral home, basic services of staff, embalming, necessary authorizations, and local transportation to airport. This charge does not include cash advance items, visitation, rites or ceremonies prior to forwarding of the remains.

This charge for immediate burial includes transfer of deceased to funeral home, refrigerated holding, local transportation to the cemetery, necessary authorizations and basic services of staff. This charge does not include cash advance items, the use of facilities and staff or any visitation or ceremony, public or private, prior to burial.
