Please note that there may be charges for items selected by you that are not described in this price list.

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any item you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Basic Services of Funeral Director and Staff

\$995

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremation, cremation with memorial service, immediate burial and forwarding or receiving remains.

This is a basic non-declinable fee that we charge every family for our professional expertise in assisting them with their preferences and are the basic services, not to be included in prices of other categories in the General Price List that are furnished by a funeral provider in arranging any funeral, such as consultation with the family, administrative and clerical services, obtaining necessary permits, consultation with the clergy, cemetery, crematory or common carrier, planning the funeral or memorial services and placement of necessary newspaper obituary notices. There will be a charge for each service requested or required.

• Embalming \$695

Except in certain special cases, embalming is not required by law. Embalming may be necessary, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial

Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are alternative containers and other cremation containers, including containers made of wood, containers made of fiberboard and containers made of other composite materials.

Our charges for direct cremation (without ceremony) include removal of the remains from the local place of death, procurement of Death Certificate, refrigeration and basic services of funeral director and staff, transportation to the crematory and basic temporary container. The crematory fee is included. Holiday or weekend, second attendant, after hour fee, witness cremation and cremation rush fees may apply as shown in our itemized price list.
