PROFESSIONAL SERVICES:

Basic Services of Funeral Director and Staff \$2,500⁰⁰

Our charge includes consultation with the family or responsible party; staff and facilities to respond to initial request for services; coordinating service plans with cemetery, crematory, and/or other parties involved in the final disposition of the deceased, securing official documents and necessary registrations for the deceased. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you selected.

Embalming \$735⁰⁰

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Other Preparation of the Deceased \$400⁰⁰

Includes cosmetology, dressing and placement of deceased into casket. This fee also includes the care and disposal of regulated waste in compliance with the Commonwealth of Massachusetts and Federal OSHA blood borne pathogen requirements.

Sanitary Care Without Embalming \$595⁰⁰

Includes the minimal care and disinfection of remains including basic preparation and sheltering of remains for up to 48 hours when no embalming is selected. This fee also includes the care and disposal of regulated waste in compliance with the Commonwealth of Massachusetts and Federal OSHA blood borne pathogen requirements.

DIRECT CREMATION*:

Our charge for a direct cremation (without ceremony) includes basic services of funeral director and staff; a proportionate share of overhead costs; transfer of deceased to the funeral home; transportation to the crematory, and a basic container. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers (fiberboard or composition material) encase the body.

IMMEDIATE BURIAL*:

Our charge for an immediate burial (without ceremony) includes basic services of funeral director and staff; a proportionate share of overhead costs; transfer of deceased to the funeral home; washing and disinfecting of deceased and transportation to cemetery.

Any deviation from our Direct Cremation Package, Immediate Burial Package, Forwarding of Remains Package, or Receiving of Remains Package will dictate that the services be individually itemized from our General Price List. I.e. graveside service, visitation, etc.

ADDITIONAL SERVICES:

Pre-Arrangement Services:

We can help you pre-plan funeral arrangements for greater peace of mind. Information is available at no cost or obligation by telephone or by scheduling an appointment.

Infant Services:

These services involve minimum staff services, securing necessary permits, sanitary care, newspaper notices, arranging for cemetery, clergy (if requested) and local transportation. The family pays for cash advance items, cost of casket, and any applicable clergy, cemetery or crematory costs. There is no funeral home charge for miscarried, stillborn or infants under one year.

Children Services:

These services involve much work and staff time and are similar to an adult service. However, due to the circumstances and so as not to inflict a financial burden on the family, the charges for our professional services will be reduced by 50 percent as a compassion credit to the family. (Ages 14 and Younger)
