The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Basic Services of Funeral Director and Staff and Overhead.....\$2,200

Our services include: conducting the arrangements conference; planning the funeral; consulting with family and clergy; shelter of remains; preparing and filing of necessary notices; obtaining necessary authorizations and permits; coordinating with the cemetery, crematory, or other third parties. In addition, this fee includes a proportionate share of our basic overhead costs. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

Embalming\$775

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement, such as direct cremation or immediate burial, that does not require you to pay for it.

House Bill 481 Embalming/Refrigeration Requirement (section 4717.13.A10): If final disposition of a dead body has not occurred within 48 hours of the time of death, Ohio law requires that the body be embalmed or refrigerated at 40 degrees or less and the family may be charged for the services.

Other Preparation of the Body\$400

This includes casketing of unembalmed human remains into a casket or other alternative container. This also includes holding of the deceased in a sanitary, secure and refrigerated environment (7 days). The sanitary holding and refrigeration of the un-embalmed body permits us to provide a safe, dignified and properly maintained working environment. This does not include the public viewing of the deceased.

Transfer of Remains to the Funeral Home (within 35-mile radius)\$500

beyond this radius we charge \$2.50 per mile

Forwarding of Remains to Another Funeral Home \$3,445

Our charge includes: basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; preparation of remains including embalming and local transportation.

Receiving Remains from Another Funeral Home \$4,970

Our charge includes: basic services of funeral director and staff; a proportionate share of overhead costs; care of remains; transportation of remains to funeral home and to cemetery or crematory.

Direct Cremation \$2,950 to \$5,625

Our charge for a direct cremation (without ceremony) includes: basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; harboring and refrigeration (3-days), transportation to crematory; necessary authorizations and crematory fee. If you want to arrange a direct cremation, you must use an alternative container. The containers we provide are a cardboard container or a wood bottom cardboard container.

Alternative Containers: As used in sections 4717.20 to 4717.30 of the Ohio Revised Code: "Alternative container" means a receptacle, other than a casket, in which a dead human body or body parts are transported to a crematory facility and placed in the cremation chamber for cremation, and that meets all the following requirements:

- (1) Is composed of readily combustible materials that are suitable for cremation;
- (2) May be closed to provide a complete covering for the dead human body or body parts;
- (3) Is resistant to leakage or spillage;
- (4) Is sufficiently rigid to be handled readily;
- (5) Provides protection for the health and safety of crematory personnel.

Immediate Burial \$3,525 to \$5,025

Our charge for an immediate burial (without ceremony) includes: basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; disinfection, washing and casketing of the remains and local transportation to cemetery.
