# BURIAL SERVICE PACKAGES

*ALL SERVICE PACKAGES (excluding Simple Cremation Packages) INCLUDE A WEEKEND CONVIENCE FEE*

*All burial service packages include, unless otherwise noted: Proportionate amount of general overhead expenses, professional services of the funeral director and staff, initial removal from the place of death (within 35 miles of Fairport Harbor, OH), use of facilities and staff and/or equipment and staff for services, embalming and/or harboring (refrigeration) of deceased, hearse, service & utility vehicles.*

**Traditional Funeral Service \*\*** ..... \$ 6,840  
Two days of visitation followed by a service on the third day at the funeral home or a church

**Customary Funeral Service \*\*** ..... \$ 6,340  
One day of visitation followed by a service on the second day at the funeral home or a church

**Combined Funeral Service \*\*** ..... \$ 5,840  
Visitation and funeral service held on the same day at the funeral home

**Church Only Funeral Service \*\*** ..... \$ 6,590  
One day of visitation followed by a funeral service the following day, all happening at a church

**Graveside Committal Service with Embalming \*\*** ..... \$ 5,440  
Immediate family is invited to meet at the funeral home for a private visitation before processing to the cemetery for a public or private graveside service

**Graveside Committal Service with no Embalming \*\*** ..... \$ 4,750  
Friends and family are asked to meet at the cemetery for a public or private graveside service. Includes state required refrigeration.

**Green Combined Funeral Service w/ no Embalming\*\*** ..... \$ 5,450  
This includes on morning visitation followed by a funeral service with procession to the place of committal immediately following. No embalming is done to the body. This includes state required refrigeration of the decedent.

**Combined Funeral Service w/ Green Embalming\*\*** ..... \$ 6,140  
This includes on morning visitation followed by a funeral service with procession to the place of committal immediately following. The body is preserved using non-formaldehyde chemicals.

*-Additional transportation charges may be incurred if any portion of service takes place outside 35 mile radius.*

# CREMATION SERVICE PACKAGES

*All cremation service packages include, unless otherwise noted: Proportionate amount of general overhead expenses, professional services of the funeral director and staff, initial removal from the place of death (within 35 miles of Fairport Harbor, OH), use of facilities and staff and/or equipment and staff for services, embalming and/or harboring (refrigeration) of deceased, hearse, service & utility vehicles and a simple wood urn.*

**Traditional Funeral Service followed by Cremation\*\* ..... \$ 7,490**

Traditional with no cemetery and no additional vehicles ..... \$ 6,590

Two days of visitation followed by a service on the third day. The cremation will take place after the service and a graveside service will be scheduled for a following day. A rush fee will be assessed should the cremation need to take place following visitation for burial Immediately following the service.

**Customary Funeral Service followed by Cremation \*\* ..... \$ 6,990**

Customary with no cemetery and no additional vehicles ..... \$ 6,090

One day of visitation followed by a service the following day. The cremation will take place after the service and a graveside service will be scheduled for a following day. A rush fee will be assessed should the cremation need to take place following visitation for burial immediately following the service.

**Combined Funeral Service followed by Cremation \*\* ..... \$ 6,490**

Combined with no cemetery and no additional vehicles..... \$ 5,590

The visitation and service take place on the same day with the graveside scheduled for a day following the completion of the cremation.

**Cremation followed by a Customary Memorial Service\*\* ..... \$ 6,475**

Customary Memorial Service with no cemetery and no additional vehicles..... \$ 5,825

Visitation one day with the memorial service on the following day (2 days). After the memorial service at the funeral home, family and friends will process to the cemetery. Includes Hearse & Escort Vehicle

**Cremation followed by One Standard Memorial Service\*\* ..... \$ 5,975**

Memorial Service with no cemetery and no additional vehicles ..... \$ 5,325

Following the memorial service or visitation/gathering at the funeral home, family and friends will process to the cemetery. Includes Hearse & Escort Vehicle

**Cremation followed by a Committal Service\*\* ..... \$ 5,275**

Committal Service meet at cemetery (Only Service Vehicle Included) ..... \$ 4,575

Immediate family is asked to meet at the funeral home for a private family viewing prior to a procession to the cemetery where friends and extended family are asked to meet. Includes Hearse & Escort Vehicle

# SIMPLE CREMATION PACKAGES

***Immediate Cremation with no services\** ..... \$ 3,775 to \$ 3,915**

The above cost includes the charge for a minimal wood lined alternative container, a simple wood urn, retrieval of certified death certificates from the health department (Lake & Geauga Counties), state required refrigeration of the deceased at our secure facility (up to 7 days), assistance in writing and submitting an obituary and/or death notice, publishing the obituary or death notice on our website/Facebook. Arrangement conference will occur at the convenience of the family and a state required identification viewing (up to 4 people for 15 minutes, not a public visitation) will be held at any of our funeral homes or may be done via photograph.

*-The above cost does not include use of the facilities except for a state required identification viewing, merchandise other than expressly stated, cemetery fees or cash advanced items, such as newspaper notices, death certificates, clergy fees etc.*

***Simple Direct Cremation with no services\** ..... \$ 2,750**

The above cost includes state required refrigeration up to three (3) days. Arrangements will be made virtually Monday through Friday, from 10am to 3pm. All correspondence will be done via email.

The above costs do not include charges for an alternative container, permanent or temporary urn, merchandise, cemetery fees, assistance with writing and publishing an obituary or death notice, retrieval of certified death certificates or cash advanced items, such as newspaper notices, death certificates, clergy fees etc.

***Alternative Containers:*** As used in sections 4717.20 to 4717.30 of the Ohio Revised Code: “Alternative container” means a receptacle, other than a casket, in which a dead human body or body parts are transported to a crematory facility and placed in the cremation chamber for cremation, and that meets all the following requirements:

- (1) Is composed of readily combustible materials that are suitable for cremation;
- (2) May be closed to provide a complete covering for the dead human body or bodyparts;
- (3) Is resistant to leakage or spillage;
- (4) Is sufficiently rigid to be handled readily;
- (5) Provides protection for the health and safety of crematory personnel.

# ITEMIZED FUNERAL COSTS

*The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, an explanation will be provided on the statement of funeral goods and services.*

## Basic Services of Funeral Director, Staff, and Overhead ..... \$ 2,200

The above services include: Twenty-four-hour accessibility; general and administrative expenses; arrangement conference; the planning, supervising, and coordinating service details with those involved in the funeral or memorial service; securing, preparing, and filing necessary permits, certificates, authorizations and consents; clerical and record-keeping. In addition, this fee includes a proportionate share of our basic overhead costs, such as, utilities, accounting and legal fees, insurance, etc. This fee for basic services and overhead has already been added to the funeral service packages.

## Embalming Services ..... \$ 790

This fee for embalming services includes: Topical and arterial preservation and disinfection, washing and dressing of remains, casketing; cosmetology, and hairdressing, as well as medical waste disposal.

***House Bill 481 Embalming/Refrigeration Requirement (section 4717.13.A10):*** *If final disposition of a dead body has not occurred within 48 hours of the time of death, Ohio law requires that the body be embalmed or refrigerated at 40 degrees or less and the family may be charged for the services.*

## Harboring of Un-Embalmed/Receiving from Out of Town ..... \$ 400

This includes casketing of unembalmed human remains into a casket or other alternative container. This also includes holding of the deceased in a sanitary, secure and refrigerated environment (7 days). The sanitary holding and refrigeration of the un-embalmed body permits us to provide a safe, dignified and properly maintained working environment. This does not include the public viewing of the deceased. An additional charge of \$45 per day will be incurred after 7 days of harboring.

 Visitation is held, customarily 2-4 and 6-8pm or 5-8pm and includes: Set-up and use of facilities, furnishings and equipment; hospitality services, placement of casketed or other remains; receipt and display of floral arrangements; supervision and attendance before, during and after the periods of visitation.

Each Additional Day ..... \$ 500

Additional Hourly Charge after 4 published ..... \$ 150

Private Visitation for the Family Only (Two Hour limit)..... \$ 300

Funeral or Memorial Ceremony at the Funeral Home, Church, or Other Facility ... \$ 700  
 Includes: Set-up and use of facilities, furnishings and equipment; hospitality services, placement of casketed remains, cremation ark and/or urn; receipt and display of floral arrangements; supervision and attendance before, during and after the funeral. ***If a facility is chosen other than the funeral home, additional honorariums and fees may occur.***

# GRAVESIDE COMMITTAL SERVICES INFORMATION

It is important for our families to feel comfortable with the graveside committal services, so it is important we advise you of some of the procedures, problems and solutions.

1. The personnel of the cemetery and/or the vault company will determine the safest location for a cemetery committal service. If the area around the gravesite, *in their judgment*, is considered unsafe, (due to instability of the gravesite, grade and topography of the ground, placement of other grave markers, uneven ground, snow, ice, etc.,) a more suitable and safe location as near as possible to the gravesite may be necessitated for the safety of the family and their guests. This is called a “false set-up.” In most cases, the funeral home personnel **will not** know if a false set-up has been chosen. In the event we are advised in advance, we will make every attempt to notify the family.
2. The cemetery and/or vault company personnel may be present to help park cars, handle floral arrangements, assist in placing the casket on lowering equipment, removing the funeral procession flags, etc. They will then leave the gravesite area.
3. Some heavy equipment, such as the vault buggy, back hoes, trucks, etc., may also be in the area near the grave, as well as the Outer Burial Container top and/or base. The personnel will make every effort to keep them removed from the immediate area about the gravesite if possible.

# Payment Policy
