## TO THOSE WE ARE PRIVILEGED TO SERVE:

It is our goal to make sure that your family is served with the utmost of care, compassion and professionalism. We want to provide your family with the knowledge and understanding to make the best decisions for your loved one's services. Please feel free to address any questions or concerns that you may have regarding the costs or services. We are here to ease your mind and to assure you and your family of the services that you deserve.

Prior to drafting any contract for goods and services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent. Please note that there may be charges for items selected by you that are not described in this price list.

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any item you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

- **Basic Services of Funeral Director and Staff** \$795  
This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremation, cremation with memorial service, immediate burial and forwarding or receiving remains. This is a basic non-declinable fee that we charge every family for our professional expertise in assisting them with their preferences and are the basic services, not to be included in prices of other categories in the General Price List that are furnished by a funeral provider in arranging any funeral, such as consultation with the family, administrative and clerical services, obtaining necessary permits, consultation with the clergy, cemetery, crematory or common carrier, planning the funeral or memorial services and placement of necessary newspaper obituary notices. There will be a charge for each service requested or required.
  
- **Embalming** \$395  
Except in certain special cases, embalming is not required by law. Embalming may be necessary, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.
- **Other preparation of the body (dressing, casketing and/or cosmetology)** \$195  
(Additional charge for hairdressing) \$100
- **Refrigeration (when embalming is declined) Required by law after 24 hours** \$395
- **Care and Custody while Sheltering Remains-Per Day (After 10 days)** \$100
- **Private Viewing/Identification of un-embalmed remains including sanitary care** \$125  
This option is for those families that do not choose traditional funeral services and require a final viewing/identification of their loved one before final disposition. This brief (up to 15 minute) opportunity is conducted in our Care Center and is limited to no more than 5 people of legal age. When this option is elected, sanitary care for family viewing may be required.
  
- **Use of Facilities and Staff for Visitation (4 hours)** \$495  
(Use of Facilities and Staff for One Hour Visitation) \$200
- **Use of Facilities and Staff for Funeral Ceremony/Memorial Service** \$595

- **Use of Equipment and Staff for Church or Other Facility Service** \$595
- **Use of Equipment and Staff for Graveside Service** \$395
  
- **Local Transfer of Decedent to the Mortuary** (within 30 miles radius of funeral home) \$395  
(Additional charge required for 2<sup>nd</sup> person on residence removals) \$100
- **Service Utility Vehicle** \$195
- **Hearse for Funeral Service** \$395  
(All vehicle fees apply within a 30 mile radius. \$3 per mile over 30 mile radius)
  - **Utility Vehicle for procurement of Certified Death Certificate(s) from Registrar's Office** \$125
  - **Weekend and Holiday Service Fee** \$495

## *Service Packages*

### ***Traditional Chapel/Church Service \$3460***

Basic services of funeral director and staff, local transfer of deceased to mortuary, processing and filing of Death Certificate and Permit, embalming, other preparation of body, hearse, flower vehicle, use of facilities and staff for visitation, use of facilities and staff for funeral ceremony, use of equipment and staff for graveside service.

### ***Traditional Graveside Service \$3260***

Basic services of funeral director and staff, local transfer of deceased to mortuary, processing and filing of Death Certificate and Permit, embalming, other preparation of body, hearse, flower vehicle, use of facilities and staff for visitation, use of equipment and staff for graveside service.

### ***1-Hour View/Graveside \$2965***

Basic services of funeral director and staff, local transfer of deceased to mortuary, 1-Hour Viewing, processing and filing of Death Certificate and Permit, embalming, other preparation of the body, hearse, flower vehicle and use of equipment and staff for graveside service.

### ***Traditional Chapel/Church Cremation with Service \$3390***

Basic services of funeral director and staff, local transfer of deceased to mortuary, processing and filing of Death Certificate and Permit, embalming, crematory fee, other preparation of body, use of facilities and staff for visitation, use of facilities/staff for funeral service.

### ***Cremation with Memorial Service \$1490***

Basic services of funeral director and staff, local transfer of deceased to mortuary, refrigeration, processing and filing of Death Certificate and Permit, crematory fee, alternative container, use of facilities and staff for memorial service.

### ***Cremation with Graveside Service \$1290***

Basic services of funeral director and staff, local transfer of deceased to mortuary, processing and filing of Death Certificate and Permit, refrigeration, crematory fee, alternative container, use of equipment and staff for graveside service.

**The above service packages have been designed to simplify your arrangement process. These packages do not include burial caskets, vaults, flowers, memorial products and/or cash advance items. Your counselor will kindly provide all of your options. Your family may also select services from the itemized section of the General Price List.**

- **Direct Cremation** – If you want to arrange a direct cremation, you may use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are alternative containers and other cremation containers, including containers made of wood, containers made of fiberboard and containers made of other composite materials.

Our charges for direct cremation (without ceremony) include removal of the remains from the local place of death, processing and filing of Death Certificate and Permit, refrigeration and basic services of funeral director and staff, transportation to the crematory and basic temporary container. The crematory fee is included. Holiday or weekend, second attendant, after hour fee, witness cremation and cremation rush fees may apply as shown in our itemized price list.

### **Direct Cremation Cost**

- **Cremation Urns start at** \$50
- **Alternative Containers start at** \$15

- **Forwarding of Remains to Another Mortuary and / or Funeral Home** \$1695

This charge includes local removal of the deceased, minimum services of our staff, necessary authorizations, embalming, use of preparation room, processing and filing of Death Certificate and Permit, shipping container or combination air tray, and transportation to Ontario Airport

• **Receiving remains from Another Mortuary and / or Funeral Home** \$1295

This charge includes minimum services of our staff, processing and filing of Permit, transportation from Ontario Airport, and transportation of remains to cemetery or crematory.

• **Immediate Burial** \$1495

Our charges for Immediate Burial (without any rites or ceremonies at the mortuary, graveside or elsewhere) include removal of the remains from the local place of death, refrigeration, processing and filing of Death Certificate and Permit and minimum services of the funeral director and staff and transportation to the cemetery (within a 30 mile radius).

• **Insurance Processing** \$300

Mark B Shaw will assist in filing insurance claims and at request assign proceeds to pay for funeral services. **The minimum accepted amount of assignment is \$1500.** We reserve the right not to accept an assignment from any insurance company not willing to cooperate and pay proceeds within 30 days from the date of death.
