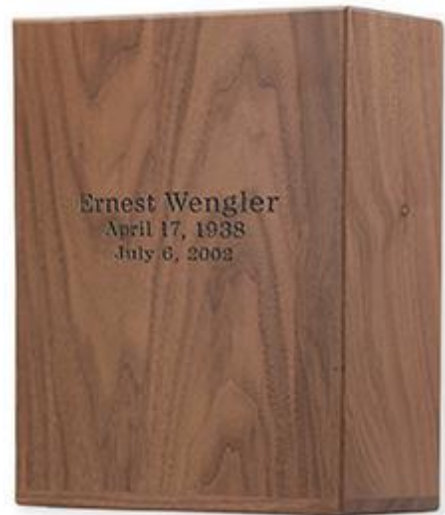

## General Price List / Casket Price List

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Prior to drafting any contract for goods or services, the responsible party or the decedent’s survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent. These prices are effective January 1, 2019 and are subject to change without notice.

### Cremation Plans

**Direct Cremation - Standard** ..... **1,340 – 1,800**  
 Includes basic services of funeral director and staff, proportionate share of overhead, consultation with family, local transfer of remains to funeral home, crematory fee, preparation and filing of necessary documents and certificates, choice of select cremation container and memorial urn.

**Direct Cremation - Preferred** ..... **1,875 – 2,325**  
 Includes basic services of funeral director and staff, proportionate share of overhead, consultation with family, local transfer of remains to funeral home, crematory fee, preparation and filing of necessary documents and certificates, expedited return of cremated remains, procurement of certified copies of death certificate, choice of select cremation container and memorial urn

### Itemized Pricing

**Minimum Services of Funeral Director and Staff and Overhead** ..... **895**  
 This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select (this fee is already included in our charges for direct cremations, immediate burials, and forwarding/receiving remains). This fee includes the following: Personnel available 24 hours a day, 365 days a year to respond to initial call, coordinating with cemetery, crematory, and/or other parties involved in the final disposition of the deceased, clerical assistance in the completion of various forms associated with services rendered, securing and recording the death certificate and disposition permit. Also covers overhead, including facility maintenance, equipment and inventory costs, insurance and administrative expenses, and governmental compliance.

**Embalming** ..... **875**  
 Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation/immediate burial.

**Transfer of Remains to Funeral Home** (within 30 mile radius)..... **575**  
 Beyond this radius, \$4.75 per mile (each way), transfers requiring two personnel add: \$145. /after business hours (mon-fri 9am-5pm): \$145.

**Mileage** (transportation to place of disposition or transfer beyond 30 miles from funeral home) ..... **4.75/mile**

**Refrigeration** (up to 3 days/each additional day: \$75) ..... **375**

**Forwarding of Remains to Another Funeral Home** ..... not available

**Receiving Remains from Another Funeral Home** ..... **1,975**  
 This charge includes: minimum services of staff, transportation from Sacramento International Airport, transportation of remains to crematory.

**Direct Cremation** ..... **995**  
 Our charge for a direct cremation (without ceremony) includes: minimum services of staff, local transfer of remains to funeral home, up to three days refrigeration, transportation to crematory, crematory fee. If you want to arrange a direct cremation, you can use an alternative container with or without and outside covering. Alternative containers encase the body and can be made of materials like wood, fiberboard, or composition materials. This container can be provided by either Foothill Cremation or the consumer. The alternative containers we offer for cremation range in price from \$125 to \$575. A complete list of Alternative Containers will be provided at the funeral home.
