

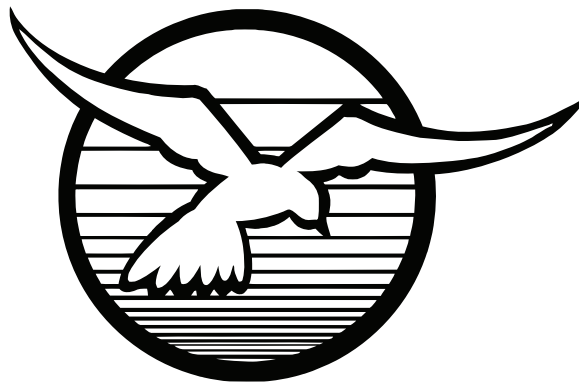

SERVICES OF FUNERAL DIRECTOR AND STAFF.....**\$2,850.00**

Our fee for the services of funeral director and staff includes, but is not limited to, staff to respond to initial request for Service; arrangement of funeral; preparation and filing of necessary notices, authorizations and permits; recording vital statistics; preparation and placement of obituary notices; staff assistance prior to, during and following the funeral, including coordination with those providing portions of the funeral, e.g. cemetery, crematory and others. Also included in this charge are overhead expenses relative to our facility such as insurance, maintenance and utility expenses, secretarial and administrative costs, and equipment and inventory expenses.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremation, immediate burials, and forwarding or receiving remains.)

FORWARDING OF REMAINS TO ANOTHER FUNERAL HOME.....\$3,995.00

This charge includes removal of the remains, minimum services of staff, embalming when required for transportation, minimum shipping container for remains, necessary authorizations, local transportation to airport or railhead. It does not include the services of staff for the use of facilities for any visitation and/or rites or ceremonies prior to the forwarding of the remains.
