If legal or other requirements mean you must buy any items you did not specifically ask for; we will explain the reasons

In writing on the statement, we provide describing the funeral goods and services you selected.

**Basic Services of Funeral Director and Staff.....\$3,200.00 \***

Our **Professional Service Fee** includes, but is not limited to, staff to respond to initial request for service; arrangement conference with family or responsible party; preparation and filing of necessary certificates and permits; shelter of remains; placement of obituary notices; planning of funeral arrangements; coordination of service with cemetery, crematory, vault companies and others as required. Also included in this charge are overhead expenses relative to our facility, such as insurance, maintenance and utility expenses, secretarial and administrative costs, and equipment and inventory expenses. This fee for our basic services and overhead will be added to the total cost of funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

**All items with an (\*) below are added to the Basic Services fee above, if a full service is selected.**

**- Does not include casket, outer burial container, and other merchandise or cash advance items.**

**Embalming: .....\$ 900.00 \***

Except in certain special cases, embalming is not required by law. Embalming may be necessary. However, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.
