If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

CALIFORNIA SALES TAX WILL BE ADDED TO ALL TAXABLE ITEMS. This list does not include prices for certain items that you may ask us to buy for you; such as, but not limited to, outside cemetery services, or crematory services, flowers, motorcycle escorts for outside processions, and newspaper notices. The charge for these items will be shown on your bill or the statement describing the funeral goods and services you selected. We charge you for our service for placement of newspaper notices and ordering flowers, including cost of such items.

Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.

PROFESSIONAL SERVICES:

SERVICES OF THE FUNERAL DIRECTOR AND STAFF \$ 2,225.00

Our service charge includes consultation with the family, clerical and administrative service, preparation of the death certificate and filing of necessary permits, coordinating the details with cemetery, crematory and/or other parties responsible for the arrangements made. Also a percentage of this fee is necessary to cover a proportionate share of our established overhead cost such as licenses, insurance, and indirect taxes (does not include sales tax on items in the merchandise category), maintenance of facilities and equipment, utilities and a host of other cost related to being in business to serve the public. This fee for our basic services and overhead will be added to the total cost of the funeral arrangement you select. **(This fee is already included in our charges for direct cremations, immediate burials, and forwarding remains.)**

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require it, such as direct cremation or immediate burial. If embalming is declined and the final disposition of the deceased is not completed within 8 hours from the time of death, we require refrigeration.
