The following pages consist of our General Price List, Casket Price List and Outer Burial Container Price List, in compliance with the Federal Trade Commission's "Funeral Rule" for your information and benefit. Included within these price lists, there are several disclosures that are required by either Federal or State law. At the time you receive this packet, your director will tell you about all of these disclosures and request that you sign and date forms that indicate that you Received all of them, both verbally and in print.

"Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is Entitled to receive a copy of any pre-need agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent."

Authority cited: Business and Professions Code (BPC) Sections 7685(b), 7685.6, and 7745 and California Code of Regulations (CCR) Section 1258.4

***NOTICE REGARDING CREMATED REMAINS:** A person having the right to control disposition of cremated remains may remove the remains in a durable container from the place of cremation or interment, pursuant to Section 7054.6 of the Health and Safety Code.

If the cremated remains container cannot accommodate all cremated remains of the deceased, the crematory shall provide a larger cremated remains container at no additional cost, or place the excess in a second container that cannot easily come apart from the first, Pursuant to Section 8345 of the Health and Safety Code.

****All information given to the counselor at the time funeral arrangements are made must be correct vital information prior to filing with the State of California. It is the contracting party's responsibility to provide the counselor with the correct information. If the information given is incorrect after the filing process has taken place, the death certificate must be amended. This can take several weeks and you will be responsible for all additional charges incurred to amend and order corrected copies of the death certificate.**

Embalming	Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as a direct cremation or immediate burial	\$900.00
