The goods and services shown below are those we can provide our customers. You may choose only the items which you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

No. 1. Minimum Services of Funeral Directors, Staff and Facilities

This fee is for our basic service and overhead will be added to the total cost of the funeral arrangements you select. (This fee will also be included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.) The items included in this charge are the constant expenses, and contribute heavily to our overall cost of doing business. Items included in this charge are staff and facilities to respond to initial requests for service, arrangement conference, preparing notices, obtaining certificates and permits, planning the funeral, support staff, group insurance, Social Security and other government contributions, insurance, special building, office equipment and furnishings necessary, general supplies, utilities, property taxes, accounting and legal fees, postage, licenses, collection expenses, dues, subscriptions, public information and necessary permits.

No. 2. Additional Personal and Professional Services and use of Funeral Home Facilities and Equipment:

Funeral home facilities including the use of the funeral home public areas, parking lot and offices, supplies and equipment, use of the funeral home chapel, furnishings, equipment for visitation and the requested services or extra time and effort required for a church service.

- A. Coordination and direction of the funeral ceremony conducted at the church/chapel \$710.00
- B. Coordination and direction of the funeral ceremony conducted at the place of final disposition in lieu of church/chapel \$425.00

No. 3. Embalming and General Preparation

This fee includes embalming, cosmetics, dressing, restorative work, and casketing. Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

This list does not include prices for certain items you may ask us to buy for you, such as cemetery or crematory services, flowers, organist, soloist, clergy, or extra transportation charges. The prices for those items will be shown on your bill or the statement describing the funeral goods and services you selected.

If, for any reason, you are not satisfied with professional services produced by the Sanders Funeral Service, we will refund the monies paid for the specific service upon presentation of a written request within seven (7) days of the service.

Full Traditional Funeral Service \$5,635.00

This fee includes: Minimum charge for services of Funeral Directors, Staff and Facilities; Coordination and Direction of the Funeral Ceremony conducted at the church/chapel; supervision and attendants for Visitation, Embalming and Technical Care; use of Funeral Home Facilities and Equipment for Visitation and the Funeral Ceremony or Church Ceremony; use of all Automotive Equipment plus 14 Passenger Limousine; Memorial Book, Thank You Cards and regular Service Folders.

Forwarding of Remains to Another Funeral Home \$3,430.00

This charge includes: Minimum charge for services of Funeral Directors, Staff and Facilities; Embalming; Transfer of Remains to Funeral Home. Also includes funeral coach and two men for transportation to Des Moines airport, and the shipping container required by each airline. (These charges **do not** include the airfare charges for human remains air flight carrier.)

Receiving Remains From Another Funeral Home \$2,125.00

This charge includes: Minimum services of Funeral Director, Staff and Facilities; Coach for cemetery, and transportation from Des Moines, IA airport. (It **does not** include facilities for viewing, the funeral ceremony, vault, casket, cemetery charges, or cash advances)

Direct Cremation Service \$3,455.00

This fee includes: Minimum charge for services of Funeral Directors, Staff and Facilities; Cremation fee; transfer of remains to Funeral Home and Crematory; handling of remains; medical examiners permit and cremation container. (It **does not** include the Memorial Service or Service Folders).

The crematory requires a rigid outside container and will not allow any plastic or fiberglass material. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering.)

CREMATION CONTAINERS: \$250.00 to \$2595.00 (A complete price list will be provided at the funeral home.)

OUTER BURIAL CONTAINERS: \$960.00 to \$12550.00

CASKETS: \$1300.00 to \$9895.00 (30 to choose from)

URNS: All cremations include an urn from Aaron Sanders

SHIPPING CONTAINER: \$450.00 (Casket enclosed)

SHIPPING CONTAINER: \$250.00 (Body encased only)

SERVICES AFTER 7 DAYS OF DEATH: An additional fee of \$250.00 will be charged, plus \$50.00 per day.

Immediate Burial \$3,805.00

This fee includes: basic service of funeral director, staff and facilities; handling of remains; and removal and transfer of remains to funeral home and cemetery. (All merchandise must meet any applicable state or cemetery requirement.) Casket and/or vault may be purchased at the funeral home. (Casket or vault price is additional.)
