PROFESSIONAL SERVICES OF THE FUNERAL DIRECTOR AND STAFF----- \$ 1,955.00

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee includes the following: Personal available 24 hours a day, 365 days a year to respond to initial call; arrangements conference, coordinating services plans with cemetery, crematory, and/or other parties involved in final disposition of the deceased; clerical assistance in the completion of various documents associated with a funeral; securing and recording the death certificate and disposition permit. This fee also covers overhead, such as facility maintenance, equipment and inventory cost, insurance and administration expenses, and governmental compliance. **(This fee is already included in our charges Funeral Service Packages, Direct Cremations, Immediate Burials, and Forwarding or Receiving Remains.)**

PREPARATION OF THE BODY

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.
