Basic Services of Funeral Director and Staff					
Our charge includes funeral counseling, necessary arrangements, recording vital statistics, securing permits, filing and obtaining death certificates and other forms and claims, preparation of necessary notices, and coordination of service plans with parties involved in the final disposition of the deceased. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (this fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving remains.)

## Forwarding of Remains

This charge includes local transfer of remains, basic services of funeral director and staff, necessary authorizations, embalming and transportation to Harrisburg Airport. Charges for other services, merchandise, or use of facilities will be detailed elsewhere. This charge does not include additional mileage, shipping charges, consultation fees, casket, visitation, rites or ceremonies prior to forwarding of the remains.

## Receiving of Remains

This charge includes basic services of funeral director and staff, transfer of remains from Harrisburg Airport, transportation of deceased individual to local cemetery or crematory. Charges for other services, merchandise, or use of facilities will be detailed elsewhere. This charge does not include visitation, rites or ceremonies.

### **Body Donation**

Anatomical Gift Registry (Body Donation) \$2,895.00

This charge includes basic services of funeral director and staff, local transportation to funeral home, necessary authorizations, photo identification, and delivery to Commonwealth Medical College, Scranton, PA. Charges for other services, merchandise, or use of facilities will be detailed elsewhere. This charge does not include visitation, rites or ceremonies.

#### Direct Cremation

The charge for a direct cremation includes local removal, care of remains, transportation to crematory, basic services of funeral director and staff, and authorizations (excludes ceremony, visitation, and crematory charges). If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The minimum container we offer is cardboard. Prices exclude cash advance items.

#### Immediate Burial

The charge for an immediate burial (excludes ceremony, visitation, and cemetery charges) includes basic services of funeral director and staff, obtaining necessary authorizations, local removal of remains, dressing and casketing remains, and casket coach to local cemetery.

#### Prearranged Services

Guaranteed Prearrangement Fee.....\$250.00

This charge will be added to each item of a prearrangement that is guaranteed by the funeral home. Examples include, funeral home services, casket, vault, urn, or urn vault. Cash advance items are excluded.
