**MINIMUM ARRANGEMENTS**

**DIRECT CREMATION** . . . . . ranges \$1,075.00 and above

Our charge for direct cremation includes: limited basic services of funeral director, staff and overhead, local transfer to funeral home, refrigeration in lieu of embalming, standard cremation fee if less than 250 lbs., delivery van, if applicable, to our local crematory at our convenience.

These charges **DO NOT** include additional personnel at place of death for transfer when required, preparation of the body, viewing, funeral ceremony, merchandise, witness cremation, overweight limit cremation fees, County or State fees or taxes, or additional fees for refrigeration after two days.

This cremation will be performed within 7 working days from date of obtaining the California Permit and payment in full.

**ADDITIONAL ITEMS**

- Identification viewing . . . . . \$ 250.00

Identification viewings provide minimum preparations of the unembalmed decedent with use of I.D. room for up to 15 minutes for immediate family member only. This option **DOES NOT** allow for a public viewing, witness cremation, or any post-autopsy care.

**REGARDING PAYMENT**

All accounts are to be paid in full 72 hours (Business Days) prior to cremation, viewing, or service time. We accept Cash, Check, Cashiers Check, Money Order, Visa, Mastercard, Discover, and American Express.

Fee for all returned checks is \$25.00.
