PAYMENT POLICY

Day Funeral Service operates on a cash basis, being totally dependent upon the families we serve for prompt payment by the day of funeral service. We have adopted the following payment methods to insure that we continue providing families quality service. Payment is expected by the day of funeral arrangements. We realize that losing someone you love is a devastating experience. It can be traumatic and influence the decisions that must be made. Therefore, it is important to be realistic with respect to funeral expenditures. It is our intention that your decisions reflect your personal wishes and remain within your budget. *The following are acceptable payment arrangements:* Cash. Checks are subject to electronic funds verification. Visa, MasterCard, Discover Card and American Express have a 2.75% surcharge. Assignment of Insurance proceeds from the beneficiary (upon verification from the Insurance Company.) There is a 4% processing fee to all insurance assignments and is payable to the third party processing factor. In the event that we extend credit for 30 days, we require two (2) signatures from individuals who will accept financial responsibility for the final funeral expenses. Parties must own real estate locally or have had the same stable job for over 2 years. A late fee of 1.5% (18% annually) will be charged per month on any unpaid balance. We reserve the right to seek legal action on accounts three (3) months past due.
