SERVICES OF FUNERAL DIRECTOR AND STAFF......\$1895.00

Our professional service charge includes, but not limited to, consultation with family and clergy for direction desired, preparation and filing of necessary notices, authorizations and consents, and other services and attendance prior to, during and after the funeral including coordinating with those providing other portions of the funeral, e.g., cemetery, crematory and others.

This fee for our services will be added to the total cost of the funeral arrangements you select from the following list of services, facilities, available equipment and merchandise. You pay only for the services and items you select, however, the charges for the funeral director and staff cannot be refused.

EMBALMING......\$1195.00
