### GENERAL PRICE LIST

These prices are effective as of November 29, 2024, but are subject to change without notice.

These goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you select.

Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.

**Basic Services of Funeral Director and Staff and Overhead ..... \$1300.00**

Our services include: personnel available 24 hours a day, 365 days a year to respond to initial call; conducting the arrangements conference; planning the funeral, consulting with family and clergy; shelter of remains; preparing and filing of necessary notices, obtaining necessary authorizations and permits; coordinating with the cemetery, crematory, or other third parties. In addition, this fee includes a proportionate share of our basic overhead costs, such as facility maintenance, equipment and inventory costs, insurance and administration expenses and government compliance.

This fee for our basic services and overhead will be added to the total cost of funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving remains.)

### PREPARATION OF THE BODY

Except in certain special cases, embalming is not required by law. Embalming may be necessary however, if you select certain funeral arrangements, such as funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as a direct cremation or immediate burial.

Night, weekend and holiday removal (Additional to normal transfer fee) (All day Saturday, Sunday, and Holidays, and Between 5:00 P.M. and 8:30 A.M. on regular business days) ..... \$165.00

Funeral Vehicle (e.g. Hearse) (within Coachella Valley and Morongo Basin.) Additional distance will be charged at \$3.95 per mile (one way) ..... \$345.00

Flower Car (within 75 mile radius). Additional distance will be charged at \$3.95 per mile (one way). ..... \$195.00

Service Vehicle (within 75 mile radius). Additional distance will be charged at \$3.95 per mile (one way) ..... \$195.00

## FORWARDING REMAINS TO ANOTHER FUNERAL HOME:

This charge includes removal of remains, minimum services of staff, necessary authorizations, embalming, use of preparation room and local transportation (excluding shipping charges and shipping container). This charge does not include use of facilities and staff for visitation or ceremonies ..... **\$1795.00**

## RECEIVING REMAINS FROM ANOTHER FUNERAL HOME:

This charge includes minimum services of staff. Transportation from airport, transportation of remains to cemetery or crematory. This charge does not include visitation or ceremonies ..... **\$1495.00**

## DIRECT CREMATION: \$4610.00 TO \$1820.00

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or compositions material (with or without an outside covering).

Our charges for direct cremation (without ceremony) include: Removal of remains, transportation to crematory and minimum services of staff, refrigeration and the crematory fee.

1. Direct Cremation with container provided by the purchaser (all such container must meet any applicable state and crematory requirements) ..... **\$1820.00**
2. Direct Cremation with alternative container: Heavy Cardboard ..... **\$1895.00**
3. Direct cremation with casket purchased from our funeral home (in addition to cost of casket) ..... **\$1820.00**

## IMMEDIATE BURIAL:

Our charges for immediate burial without any rites or ceremonies at the funeral home, graveside or elsewhere include: Removal of remains, transportation to local cemetery and minimum services of staff.
