

FORWARDING OF REMAINS TO ANOTHER FUNERAL HOME

This package charge includes removal of remains to this funeral home, basic services of funeral director and staff, embalming, and obtaining necessary permits. It does not include a casket or alternative shipping container, the use of facilities and staff for any visitation or ceremony, public or private, prior to forwarding the remains, or any sheltering for days on which no post-death activities occur. Nor does it include transferring the remains to the airport or other destination, or the charges of a common carrier, or anything not expressly stated as being provided.

DIRECT CREMATION

Our package for direct cremation includes basic services of funeral director and staff, the local (within 25 miles) transfer of remains to the funeral home, the overnight sheltering of remains, the obtaining of necessary permits and authorizations, local transportation to the crematory, and sanitary care and preparation of remains for identification. This charge does not include the use of facilities and staff for any visitation or ceremony, public or private, prior to cremation, or any sheltering for days on which no post-death activities occur. Nor does it include the actual cost of the cremation process, which is a crematory charge.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composite materials (with or without an outside covering). The containers we provide are made of composite material.

RECEIVING OF REMAINS FROM ANOTHER FUNERAL HOME

This package includes receiving the remains from the other funeral home, the overnight sheltering of the remains, basic services of funeral director and staff, the obtaining of necessary permits and authorizations, and local (within 25 miles) transportation to the cemetery or crematory. This charge does not include the use of facilities and staff for any visitation or ceremony, public or private, prior to burial or cremation, or any sheltering for days on which no post death activities occur. Nor does it include transferring the remains from the airport or other source, or the charges of a common carrier, or anything not expressly stated as being provided.

IMMEDIATE BURIAL

Our immediate burial package encompasses the essential services of a funeral director and staff, local (within 25 miles) transportation of remains to the funeral home, overnight sheltering of the remains, and the acquisition of necessary permits and authorizations. It also includes local transportation to the cemetery, along with sanitary care and preparation of remains for identification.

Please note that this fee does not cover the use of facilities or staff for any visitation or ceremony, whether public or private, prior to burial, nor does it account for any sheltering on days without post-death activities. Additionally, it excludes the actual cost of the grave at the cemetery, charges for opening and closing the grave, any required outer burial container, cash disbursements, or any other services not explicitly mentioned.

BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF

Our fee for the basic services of funeral director and staff includes, but is not limited too:

1. Responding to the initial request for service
2. Conducting the arrangement conference
3. Preparation of biographical and statistical data
4. Examination of financial settlement options
5. Preparation and filing of papers, permits and authorizations
6. Coordination with those providing other services
7. Preparation and placement of obituary notices
8. Retention and care of remains prior to commencement of post death activities

This fee for our basic services will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

EMBALMING

(Including Use of Preparation Room and Sanitary Care)

Unless in specific exceptional cases, embalming is not mandated by law. However, it may be necessary if you opt for certain funeral arrangements, such as a funeral that includes viewing. If you prefer not to have embalming, you typically have the right to choose an arrangement that does not require it, such as direct cremation or immediate burial.

Should you decide to proceed with embalming, the procedure can take place at a location other than the registered mortuary.

Please note that in New Jersey, human remains cannot remain unburied or uncremated for more than 48 hours unless embalmed or refrigerated. (N.J.A.C. 8:9-1.1)
