

### **Compare Prices**

The Federal Trade Commission and most consumer groups encourage consumers to get competitive prices before making major purchases. House of Winston Funeral Services also encourages consumers to compare prices and services offered when selecting their funeral services.

Mortuaries do not always use the same terms. When comparing mortuary prices, it is important that you ask what is included, and what is not included, in a quoted price.

Our staff will be pleased to answer any questions you may have about our prices and services to help you make your comparison. In addition to the mortuary charges, you may also have other expenses, which are usually referred to as “cash advance” items. These included such things as minister honorariums, certified death certificates, and permits.

### **General Price List**

We are pleased to provide you with our price information. The goods and services we believe you should be well informed as to prices and requirements before making final decisions, particularly when it may be during a period of emotional distress. The goods and services shown are those we can provide to our customers. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the Agreement.

The list does not include prices for certain items such as: cemetery or crematory services, flowers, and newspaper notices. If applicable, the prices for those items will be shown on your Agreement describing the funeral goods and services you select.

Our Family Service Counselors will try to explain anything you find confusing, but nothing they or anyone else may say should be taken as modifying or differing with the written words in this document and on the statement describing the goods and services you select (Agreement). That Agreement will show, in as simple form as possible, your final selections, the prices, and what goods and services are included. You will be shown that Agreement before you sign it and will be given a copy to take with you. It is the final, authoritative statement of the arrangements you have made. If you request additions or deletions to the services you wish to purchase after you sign the Agreement, these changes will be shown

on an updated invoice for you to take with you. An updated copy of the new Agreement will be signed for our records.

### **Financial Policy**

We kindly request that payment be settled at the time funeral arrangements are made. We accept cash, cashier's check, VISA, MasterCard, American Express and incontestable/assignable life insurance policies. **There will be a 3.0% credit card processing fee added to all credit card payments and a 10% processing fee on all life insurance policies added to the Cash Advance Section of your Statement of Funeral Goods and Services selected.** Any additional cash advance items selected after the Statement of Funeral Goods and Services have been prepared and signed, will be billed to the contracting party, and payment is expected within 30 days. Any outstanding invoices will incur an 18% charge each month it goes unpaid. **There will be a 25% cancellation fee deducted from refunds REQUESTED within 48 hours of scheduled service. All refunds will be issued within 5 business days of initial request.** California Sales Tax (9.75%) will be added to the cost of merchandise purchased.

All information given to the caretaker at the time funeral arrangements are made must be correct vital information prior to filing with the State of California. The contracting party is responsible for providing the counselor with the correct information. ***If the information given is incorrect after the filing process has taken place, the death certificate must be amended. This can take several weeks, and you will be responsible for all additional charges incurred to amend and order corrected copies of the death certificate.***

### **Escorts**

California State Law dictates that funeral processions on California streets/freeways/highways are required to have escorts. We at House of Winston have a two-escort minimum. **We do not allow outside escorts.** Escorts are ordered and featured on your contract; however additional escorts may be required due to the number of cars traveling to the cemetery. Therefore, you may receive a statement in the mail for the cost of additional escorts after the funeral service. It will be your responsibility to pay the escort balance on a timely manner.

### **Burial and Cremation Packages**

**Any discounted packages listed throughout this price list are available only when a casket is selected at House of Winston Funeral Services.** These prices are effective June 4th, 2026, but are subject to change without notice.

The purchaser may **NOT** add or delete any of the items in a package. Any additions to our packages will require payment in excess of the package purchase price.

### Services of Funeral Director and Staff

#### **Basic Services of Funeral Director and Staff** \$2895

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. The fee is already included in our charge for direct cremations, immediate burials and forwarding or receiving of remains. It includes the arrangement interview and coordination of service plans, accounting and general clerical administration, and our basic coverage of overhead expenses such as licenses, utilities, and business expenses required to serve the public. In addition, this fee includes the securing and recording of death certificates and obtaining the permit for disposition; the coordination of service plans with cemetery, crematory, and/or other parties involved in the disposition.

### Preparation of Remains

#### **Embalming** \$550 up to 250lbs

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements such as a funeral service with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as Direct Cremation, or Immediate Burial. There will be an additional charge of \$150 for cases **250lbs +** and additional charge of \$200 for autopsied coroner's cases.

This charge includes pick up of remains from common carrier within 40 mile one way of mortuary, transportation of remains to cemetery/crematory, burial permit and basic service of Funeral Director and Staff. This charge does not include visitation, funeral rites or ceremonies.

**Forwarding of Remains To Another Funeral Home** **\$4345**  
*With Casket Purchased With House of Winston* **\$3450**

This charge includes basic service of funeral director and staff, local removal of remains, embalming necessary authorizations, and combination unit. This charge does not include visitation or shipping costs.

**Immediate Burial (*Embalming is not required*)** **\$3895**

Disposition by burial without formal viewing, visitation, or ceremony with the body present. This includes basic services of funeral director and staff, local removal, statistical processing, refrigeration, and utility vehicle to the local cemetery.

**Direct Cremation (*Embalming is not required*)** **Starting at \$900**

Our charge for a direct cremation includes basic services of funeral director and staff, authorizations, refrigeration, transportation to crematory, \*crematory fees, retrieval of cremains from crematory, alternative container, and a plastic urn. These charges do not include scattering at sea, or other disposition or memorialization after the cremation. **\*The maximum weight of this fee is 250lbs. Additional fees will apply if maximum weight exceeds 250lbs.**
