Basic Services

\$1,995

This is the basic charge to each family we serve for our professional expertise in assisting them. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (The fee is already included in our charges for Direct Cremation, and Cremation Witnessed With Viewing packages.) This also includes an arrangement conference, preparation of the death certificate and health department permit, coordination with cemetery, air carriers, notification of Veterans Administration and Social Security and all other outside services.

Embalming

\$750

Embalming provides for the temporary preservation of the deceased. Embalming is performed by a California licensed embalmer and usually enhances the appearance of the deceased. Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing when viewing facilities require it. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as a direct cremation or immediate burial.
