The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. **However, any funeral arrangements you select will include a charge for our basic services and overhead.** If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

This list does not include prices for certain items that you may ask us to buy for you. Cash advance items will be shown on the statement describing the general goods and services you selected.

## Payment Methods

**Payment in full is expected prior to the date of services or final disposition.**

However, we realize that funeral expenses may create a financial burden for some families.

To assist in easing this burden, we accept all major credit cards.

Prior to drafting any contract for goods or services, the responsible party of the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.

**Administrative and professional services of funeral director and staff ..... 1395**

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. It includes a proportionate share of the taxes, licenses, utilities and business expenses required to serve the public. Our charge includes, 24 hour availability; arrangement consultation; administrative services; preparation of the death certificate for certification; necessary permits; filing the death certificate; consultation with clergy, cemetery, crematory or common carrier; planning, direction, and supervision of the services and disposition as determined by the family. This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains. Sales tax, certified copies of death certificates, and disposition permits are not included in any price.

**Embalming ..... 775**

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement which does not require you to pay for it, such as a direct cremation or immediate burial, or closed casket with no viewing.

Includes dressing, casketing and cosmetics.

*California Code of Regulations, Section 1223 (c): Every licensed funeral establishment and funeral director who holds unembalmed human remains for a period longer than twenty-four (24) hours shall cause the body to be refrigerated at an approved facility with sufficient capacity as defined under section 1223.1(d).*

**Other Preparation of the Body**

- Refrigeration, dressing and casketing of unembalmed remains (3 days) ..... 500
- Refrigeration of unembalmed remains (after 3 days) ..... 50 per day

**Facilities, Staff, and Equipment**

- Use of our facility and staff for chapel service (up to 2 hours) ..... 450
- Use of our facility and staff for chapel service after 4pm (up to 2 hours) ..... 600
- Use of staff for local\* off-site funeral service and/or graveside (up to 3 hours) ..... 650
- Use of our facility for family identification viewing (up to 5 people, 30 minutes) ..... 175
- Delivery of casket to residence for overnight visitation ..... 275
- Additional charge for Saturday service ..... 500
- Overtime services, per hour ..... 150
- Refundable cleaning deposit..... 300

### Minimum Services

The following packages do not include viewing, ceremonies, merchandise, or cash advances, and are provided at the convenience of the funeral home.

**Forwarding of remains to another funeral home** ..... 2395

(Does not apply to shipping outside the United States.)

Includes services of staff, local\* removal, embalming or refrigeration of remains, and transportation to local\* airport.

**Receiving of remains from another funeral home**..... 1795

Includes services of staff, service vehicle to crematory or local\* cemetery, and meeting plane at local\* airport.

**Immediate burial**..... 2095

Includes services of staff, local\* removal, embalming or refrigeration, and transportation to local\* cemetery. This is an unwitnessed burial.

### Cremation Packages

**Direct cremation package**..... 1530 to 1795

Our charge for a direct cremation (without ceremony) includes: administrative and professional services of funeral director and staff; local\* transfer of remains; refrigeration up to 3 days; transportation to the crematory; necessary authorizations; crematory fee; and having urn available for family at the funeral home. Does not include sales tax, permits, certified death certificates or shipping of cremated remains. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of material like fiberboard, or composition materials (with or without outside covering). The container we provide is our alternative cardboard container.

**Direct cremation with minimum cremation container and urn provided by purchaser**..... 1530

**Direct cremation with minimum cremation container and plastic urn**..... 1595

**Direct cremation with casket and plastic urn (does not include casket)**..... 1795

**Oversized cremation additional (300-500lbs)**..... 300

**Casket cremation additional** ..... 250

**Witness cremation additional** ..... 500

\*Local mileage is considered to be within a 25-mile radius of Claffey and Rota Funeral Home. An excess mileage rate of 4.00 per mile one-way will be charged beyond this radius.

If a container for direct cremation or immediate burial is provided by the purchaser it must meet the minimum standards of acceptance of the crematory or cemetery involved.
