The goods and services shown below are those we can provide our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Basic Services of Funeral Director and Staff and Overhead: **\$3,245**

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremation, immediate burial, and forwarding and receiving of remains).

Our basic service charge includes but is not limited to:

- ❖ Personnel available 24 hours a day, 365 days a year to respond to initial request for service.
- ❖ Arrangement conference with responsibility party to determine services desired.
- ❖ Coordinating service plans with cemetery, clergy, crematory and other parties involved in the final disposition of the deceased.
- ❖ Sheltering of remains, up to 48 hours
- ❖ Obtaining, completing and filing of death certificate, completion of necessary permits and authorizations.
- ❖ Placing of newspaper notices (classified and obituaries).
- ❖ This fee includes a proportionate share of our basic overhead expenses such as facility maintenance, equipment and inventory costs, and administrative expenses, professional licensure, legal, accounting, insurance, property taxes, utilities and repairs.

Embalming **\$ 995**

** Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement which does not require you to pay for it, such as a direct cremation or immediate burial.*

This charge does not include embalming, bathing, disinfecting, dressing, cosmetics, or the use of facilities and staff for visitation, ceremonies, and/or graveside services prior to burial or entombment.

This charge does not include cemetery, vault company, or crematory charges.

Service for Stillborn or Infant up to One Year of Age

If you want to arrange a direct cremation, you can use an alternative container.

Alternative containers encase the body and can be made of materials like fiberboard or composition material (with or without covering). The containers we provide are listed on our Cremation Casket Price List.

The containers we provide are cardboard with a wooden base, unless you make a selection from our Casket Price List.

Our charge for direct cremation (without ceremony) includes: removal of remains from place of death (\$495), basic services of funeral director and staff and overhead (\$2,835), transport to crematory (\$395).
