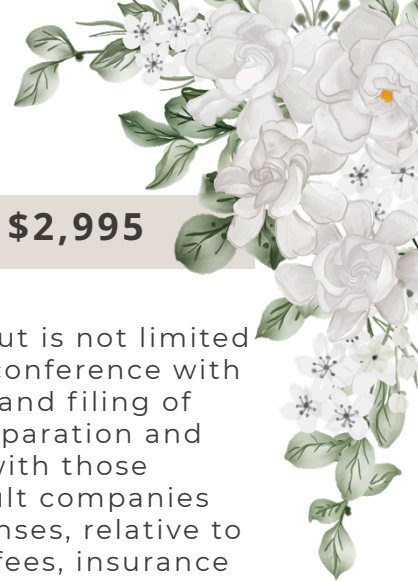

BASIC SERVICES OF FUNERAL DIRECTOR & STAFF

Our fee for the basic services a funeral director and staff include, but is not limited to, staff to respond to initial request for service and arrangement, conference with family and responsible parties arrangement of funeral preparation and filing of necessary, authorizations and permits, recording vital statistics preparation and placement of obituary notice shelter of remains and coordination with those providing other portions of the funeral e.g..cemetery crematory vault companies and others as required also included in this charger overhead expenses, relative to our facilities, such as professional, licensing, legal and accounting fees, insurance building and utility expenses, parking lot and grounds, maintenance taxes, equipment, furnishings, inventory cost, recordkeeping, secretary, and administrative expenses

This fee is for our basic services and overhead will be added to the total cost of the funeral arrangements you select.

(This fee is already included in our charge for direct cremations, immediate burial, and forwarding or receiving remains.)

EMBALMING

\$1,195

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial

FORWARDING OF REMAINS TO ANOTHER FUNERAL HOME \$5,490

This charge includes removal of remains, basic services of staff, embalming, necessary authorizations, and local transportation to an airport. This charge does not include visitation rights or any ceremonies prior to forwarding the body.

RECEIVING OF REMAINS FROM ANOTHER FUNERAL HOME \$4,295

Discharge includes pick up of remains transportation of remains to cemetery and basic service of staff discharge does not include visitation in bombing rights or ceremonies

IMMEDIATE BURIAL (COST OF CASKET IS ADDITIONAL) \$4094-\$4550

The charge for immediate burial includes removal of remains local transportation to the cemetery necessary, authorizations, and basic services of staff discharge does not include embalming the use of facilities and staff for any visitation or ceremony prior to burial

All insurance policies must be verified before a funeral date can be confirmed. All funeral service obligations paid by insurance will be assessed a 6% insurance processing fee.

- All expenses not covered by insurance must be paid in the form of personal or certified funds to Hackett Funeral Chapel, Inc. no later than the time of the first viewing.
- Upon arrival, funeral expenses may be paid by commercial credit we accept all major credit card, certified funds, and or cash
- We do not accept personal checks
