However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.*

### Professional Services

Basic Services of Funeral Director and Staff..... \$2,995.00

Our charge includes funeral counseling, necessary arrangements, recording vital statistics, securing permits, filing and obtaining death certificates and other forms and claims, preparation of necessary notices, and coordination of service plans with parties involved in the final disposition of the deceased. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (this fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving remains.)

### Care of Remains

Embalming ..... \$695.00

Embalming of Organ / Bone / Tissue Donors or Autopsied Remains ..... \$995.00

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Grooming, Dressing, Cosmetic Application, Casketing, and Restoration ..... \$275.00

Disinfecting and Sanitary Procedures for Unembalmed Remains ..... \$275.00

Refrigeration of Remains (per day)..... \$150.00

### Direction of Services and Use of Facilities

Funeral or Memorial Service (Conducted at Funeral Home or Other Local Facility) ..... \$395.00

Viewing or Visitation (Conducted at Funeral Home or Other Local Facility, Per Hour) ..... \$195.00

Identification Viewing ..... \$195.00

Limited to 30 minutes maximum, in funeral home viewing area, during normal business hours, for the purpose of identifying decedent prior to cremation. Limited to 12 people, without ceremonies. Viewing must be held within 24 hours of time of death.

Graveside Service (Meeting at Funeral Home) ..... \$595.00

Graveside Service (Meeting at Cemetery) ..... \$395.00

Funeral Director Consultation Fee (Per Hour) ..... \$150.00

This is an hourly rate, per funeral director, for consulting and administering. Examples include, but not limited to, international shipping arrangements, disinterment's, record research, filing life insurance documents, and all other services not previously itemized.

## Direct Cremation

The charge for a direct cremation includes local removal, care of remains, transportation to crematory, basic services of funeral director and staff, and authorizations (excludes ceremony, visitation, and crematory charges). If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The minimum container we offer is cardboard. Prices exclude cash advance items.
